# RESOLUTION

Honoring the memory of the victims of the tragic mid-air collision between American Airlines Flight 5342 and a United States Army helicopter on January 29, 2025.

Whereas, on January 29, 2025, American Airlines Flight 5342 and a United States Army H-60 Blackhawk collided near the Ronald Reagan Washington National Airport;

Whereas the tragic collision resulted in the loss of 67 lives, including passengers, airline personnel, and members of the Armed Forces from Kansas, Washington, D.C., and several States and countries;

Whereas the bravery, dedication, and swift action of first responders played a critical role in the rescue and recovery efforts under harsh conditions, including—

- (1) the Metropolitan Washington Airports Authority Fire and Rescue;
- (2) the Metropolitan Washington Airports Authority Police;
- (3) the District of Columbia Fire and Emergency Medical Services Department;
- (4) the Metropolitan Police Department;
- (5) the Montgomery County Fire and Rescue Service;
- (6) the Prince George's County Fire and Emergency Medical Services Department;
- (7) the Charles County Volunteer Fire and Emergency Medical Services;
- (8) the Baltimore City Fire Department;
- (9) the Baltimore Police Department;
- (10) the Anne Arundel County Fire Department;
- (11) the Maryland Department of State Police;
- (12) the Maryland Natural Resources Police;

Whereas the community, the Nation, and the world mourn the loss of those on board and recognize the profound impact this tragedy has on the families, friends, and colleagues of the victims; and

Whereas the American spirit of solidarity and support in times of crisis has once again been demonstrated through the outpouring of support, prayers, and assistance to the affected families and communities: Now, therefore, be it

1       *Resolved*, That the Senate—

2               (1) commemorates the 67 lives lost in the tragic  
3       collision of American Airlines Flight 5342 and a  
4       United States Army H-60 Blackhawk on January  
5       29, 2025;

6               (2) offers heartfelt condolences to the families,  
7       loved ones, and friends of the victims; and

1           (3) expresses gratitude to the brave law en-  
2           forcement and emergency medical personnel who re-  
3           sponded to the collision.
