## **A BILL**

To require that information on spending associated with national emergencies be subject to the same reporting requirements as other Federal funds under the Federal Funding Accountability and Transparency Act of 2006, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPORTING ON SPENDING FOR NATIONAL**  
4 **EMERGENCIES.**

5 (a) FULL DISCLOSURE OF FEDERAL FUNDS.—Sec-  
6 tion 3(b)(1) of the Federal Funding Accountability and

1 Transparency Act of 2006 (31 U.S.C. 6101 note) is  
2 amended—

3 (1) in subparagraph (C)(ii), by striking “and”  
4 at the end;

5 (2) in subparagraph (D)(ii), by striking the pe-  
6 riod at the end and inserting “; and”; and

7 (3) by adding at the end the following:

8 “(E) beginning not later than 180 days  
9 after the date of enactment of this subpara-  
10 graph, for each national emergency declared by  
11 the President under section 201 of the National  
12 Emergencies Act (50 U.S.C. 1621)—

13 “(i) the amount—

14 “(I) of budget authority appro-  
15 priated;

16 “(II) that is obligated;

17 “(III) of unobligated balances;

18 and

19 “(IV) of any other budgetary re-  
20 sources; and

21 “(ii) from which accounts and in what  
22 amount appropriations are obligated and  
23 outlays are made—

24 “(I) by object class; and

25 “(II) for each program activity.”.

1 (b) DATA STANDARDS.—

2 (1) IN GENERAL.—Section 4(b) of the Federal  
3 Funding Accountability and Transparency Act of  
4 2006 (31 U.S.C. 6101 note) is amended—

5 (A) in paragraph (6), by striking “and” at  
6 the end;

7 (B) in paragraph (7), by striking the pe-  
8 riod at the end and inserting “; and”; and

9 (C) by adding at the end the following:

10 “(8) include unique identifiers for Federal  
11 funds made available or expended with respect to  
12 each national emergency declared by the President  
13 under section 201 of the National Emergencies Act  
14 (50 U.S.C. 1621).”.

15 (2) UPDATES.—Not later than 180 days after  
16 the date of enactment of this Act, the Director of  
17 the Office of Management and Budget and the Sec-  
18 retary of the Treasury shall update the data stand-  
19 ards established under section 4(a) of the Federal  
20 Funding Accountability and Transparency Act of  
21 2006 (31 U.S.C. 6101 note) to comply with the  
22 amendments made by this section.
